



## **Redzone Announces Third Quarter Results**

Redzone Resources Ltd (“REZ” or the “Company”) reports that it has filed its unaudited consolidated financial statements for the three months and nine months ended January 31, 2015 and the related management’s discussion and analysis (“MD&A”).

The Company reported a net loss for the three months and nine months ended January 31, 2015 of \$0.1 and \$0.4 million respectively compared with \$0.3 and \$0.8 million respectively for the comparative period in 2014.

The Company has \$0.5 million in cash and remains active in its search for a value adding acquisition to see the Company to its goal of being a mid-tier mining company.
